**USE OF AUDIO AND VIDEO:** Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the Meet Referee. Use of any audio or visual recording devices, including but not limited to film and digital cameras, cell phones and tablets, is not permitted in changing areas, rest rooms or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his/her designee.

**COURSES:** All competitions to be held in short course yards.

**Burlingame High School:** Outdoor 50-meter heated pool with up to eight (8) 25-yard lanes for competition. A Warm-up and warm-down area will be available during the meet. The minimum water depth for the course, measured in accordance with Article 103.2.3, is 13'0" at the start end and 4'0" at the turn end. The competition course has not been certified in accordance 104.2.2C(4)

**Independence High School:** Outdoor 50-meter competition pool with up to fourteen (14) 25-yard lanes for competition. A separate 25-yard, seven (7) lane diving well will be available for warm- up and warm- down during the meet. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 4'5" at the start end and 7' at the turn end. The competition course has been certified in accordance with 104.2.2C(4). A copy of the certification is on file with USA Swimming.

**Gunderson High School:** Outdoor heated pool with up to sixteen (16) lanes available for competition. An additional 25-yard six (6) lane warm-up and warm-down pool may be available. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 4'6" at the shallow end and 7' at the deep end. In accordance with USA-S Article 104.2.2C (4) the competition course has been certified. A copy of the certification is on file with USA Swimming.

**Lynbrook High School:** Outdoor 50-meter heated pool, up to ten (10) 25-yard lanes for competition. Additional lanes will be available for warm-up and warm-down. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3 is 13' at the start end and 13' at the turn end. The competition course has not been certified in accordance with 104.2.2C (4).

TIME: Meets will begin at 9:00 AM with warm-ups from 7:30 to 8:30 AM. A special warm-up time for 8 and under swimmers only will be held from 8:30 to 8:50 AM. The 9/20 meet will have a delayed start at 2:15 PM with warm-ups from 1:00 to 2:00 PM.

### **RULES:**

- Current USA Swimming (USA-S) and Pacific Swimming rules will govern the meet.
- Pacific Swimming warm-up procedures will be in effect. A copy of these procedures will be posted at the venue.
- Swimmers may compete in four (4) individual events per day. Swimmers may compete in one (1) relay per day.
- All events will be swum fast to slow.
- All events are timed finals.
- All swimmers 12 & under should complete competition within four (4) hours.
- Swimmers in events 500-yards or longer must provide their own timers and lap counters.
- All coaches and deck officials must wear their USA-S membership cards in a visible manner.

**UNACCOMPANIED SWIMMERS:** Any USA-S athlete-member competing at the meet must be accompanied by a USA Swimming member-coach for the purposes of athlete supervision during warm-up, competition and warm-down. If a coach-member of the athlete's USA-S Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the swimmer or the swimmer's legal guardian to arrange for supervision by a USA Swimming member-coach. The Meet Director or Meet Referee may assist the swimmer in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the athlete's USA-S Club Member-Coach.

**RACING STARTS:** The swimmer must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start the race in the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement

## **RESTRICTIONS:**

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating or standing areas and in all areas used by swimmers during the meet and during warm-up periods.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No propane heater is permitted except for snack bar/meet operations.
- No pets or animals allowed in venue except for guide dog.
- Glass bottles / containers are prohibited in all areas of the meet venue (except for snack bar use).
- No electric or propane heaters / containers or similar devices including gasoline powered generators, other than provided for meet operations, are allowed in any areas of the meet venue.

- Except for coaches' seating next to the pool no chairs, canopies, tents, or "camping" in the competition pool area.
- Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his/her designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.

### **ELIGIBILITY:**

- Meet is open to all qualified swimmers registered with one of the CSA teams. Swimmers must be a member of BAC, EBA, LAC,
  PEAK, QSS, SEA, or WEST. Swimmers who are unattached, but participating with a member team may enter a CSA dual
  meet.
- Swimmers must be current members of USA-S and must enter their name and registration number on the meet entry card or online, as shown on their Registration Card. If this is not done, it may be difficult to match the swimmer with the registration and times database. The meet host must check all swimmer registration against the SWIMS database and if not found to be registered, the Meet Director shall accept the registration at the meet (a \$10 surcharge will be added to the registration fee). Duplicate registrations will be refunded by mail.
- Entries with "NO TIMES" will be ACCEPTED
- Disabled swimmers from those teams are welcome to attend this meet and should contact the Meet Director regarding special accommodations on entry times and seeding per Pacific Swimming policy.
- The swimmers age will be the age of the swimmer on the first day of the meet.

**ENTRIES:** A sd3 entry file must be submitted by the Tuesday prior to the meet. Request a confirmation of receipt to ensure delivery of the email and file. Send meet entry file to the meet director.

**ENTRY FEES:** \$30 per swimmer. One check must be made by the visiting team payable to the host team. Checks must be hand delivered to the meet director on the day of the meet.

**CHECK-IN:** The meets will be pre-seeded. There will be no check in.

**SCRATCHES:** There is NO penalty for a swimmer entered in this meet that misses one of his/her events.

AWARDS: None.

**ADMISSION / PROGRAMS:** Free admission. No programs will be available. Heat sheets may be available electronically and should be printed prior to arrival at the meet.

**HOSPITALITY:** Light snacks & beverages will be served to deck officials, marshals, and coaches. Coaches and Officials will be served lunch.

**SNACK BAR:** A snack bar may be available.

**SCORING:** Scoring in individual events will be as follows: 1<sup>st</sup> place = 9 points; 2<sup>nd</sup> place = 4 points; 3<sup>rd</sup> place = 3 points; 4<sup>th</sup> place = 2 points; 5<sup>th</sup> place = 1 points. Scoring in relay events will be as follows: 1<sup>st</sup> place = 11 points; 2<sup>nd</sup> place = 4 points; 3<sup>rd</sup> place = 2 points. Scoring will include boys & girls 8 & U; 10 & U; 11-12; 13-14 and 15 & Over. Meets will be scored as dual meets with each team scored against each of the other teams in sets of two.

**MISCELLANEOUS:** Each team is required to provide timers. Meet director will email timer/lane assignments to each team prior to the meet.
