The results of this meet may be posted in real time on the Internet via the Meet Mobile: Swim app.

USE OF AUDIO AND VISUAL: Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the Meet Referee. Use of any audio or visual recording devices, including, but not limited to, film and digital cameras, cell phones and tablets, and Google Glass, is not permitted in changing areas, rest rooms, or locker rooms. Violation of this recording prohibition may result in ejection from the venue by the Meet Referee or their designee.

ZONE 2 ALL-STAR TEAM SELECTION: This is also a **selection meet** for the Pacific Swimming Zone All-Star Meet (ZAM). ZAM will be held on March 3, 2024 in Carson City, NV. The Zone 2 All-Star Team will be comprised of up to eight girls and eight boys from each of four age groups (8 & under, 9–10, 11–12, and 13–14) for a total of up to 64 athletes. The selection for seven athletes in each gender of each age group will be determined by the total number of points scored in the **ZAM selection events** at the 2024 Zone 2 Winter Championship Meet. The eighth athlete in each gender of each age group will be a coach's choice. The next two highest-scoring applicants will be Alternates.

To be considered for the Zone 2 All-Star Team, each applicant or their legal guardian must perform the following **2 steps**:

1. **Enter and compete** in at least one of the ZAM selection events listed in the table below. **Note:** The athlete's age group for ZAM Team Selection is based on the Athlete's age on March 3, 2024.
Competing in more selection events increases the chance of selection.
2. **Complete and submit** the Initial Application online no later than **Friday, February 2, 2024 at 6:00 PM** -or- provide the athlete's information to the Zone 2 All-Star Team desk at the meet **before Saturday, February 3, 2024 at 9:00 AM.**

Only times achieved at the 2024 Zone 2 Winter Championship Meet will be considered for points allocation and team selection. Points will be scored based on the applicant's age group on March 3, 2024. LOCATION: *Chris Kjeldsen Pool* at Douglass M Eberhardt Aquatics Ctr, University of the Pacific (UOP). 1163 Larry Heller Dr, Stockton CA 95211.

DIRECTIONS: From **I-5 N**, take exit 473 (Pershing Avenue/University of the Pacific) and continue straight onto N Pershing Ave. In 1.2 mi, turn right onto Larry Heller Dr. The pool will be on the left (0.2 mi/1000 ft).

From **I-580 E**, take left exit 65 (I-205 Tracy/Stockton) and continue onto I-205 E. In 14.5 mi, merge onto I-5 N. Follow remaining directions from **I-5 N**.

From **CA SR-4 E**, continue onto W Charter Way/CA SR-4. Follow signs for I-5 N/CA SR-4 (Sacramento), turn left onto the I-5 N on-ramp. Keep left at the fork to stay on I-5 N. Follow remaining directions from **I-5 N**.

PARKING: Parking is available at UOP Parking Lots 1, 2, and 4. All users of parking facilities agree to obey all parking and traffic regulations. Vehicles in violation of University Parking Regulations are subject to citation and may be towed. Permit parking is *not* enforced on weekends.

COURSE: Outdoor 25-yard pool with up to 16 lanes available for competition. The minimum water depth, measured in accordance with Article 103.2.3 is 9 ft on the start end and 9 ft on the turn end. The host will ensure the required course dimensions. A 25-yard lane space will be available for warm-up/warm-down throughout the competition.

TIME: Meet will begin at 9:00 AM each day. General warm-up will be from 7:30–8:45 AM each day. A restricted warm-up time for 8 & under athletes will be from 8:45–8:55 AM.

- RULES:**
- Current USA Swimming and Pacific Swimming rules and warm-up procedures will govern the meet. A copy of these procedures will be available at the Clerk of Course.
 - The local facility’s guidelines, restrictions, and interpretation of the local public health guidelines shall be followed at this meet.
 - All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.
 - All events are timed finals.
 - All events will swim FAST to SLOW.
 - Athletes may compete in up to four (4) individual events per day, plus relays.
 - **Bonus Events:** Athletes who meet the minimum time standard in at least one event for the meet may enter up to two bonus events per day.
 - Individual and/or relay events may be seeded together, without regard to swimmers’ ages or gender, in the order of submitted entry time. Places, awards, and published results for these events will be separate for each age group and gender (Article 102.1.5)
 - If local conditions warrant it, the Meet Referee, with the concurrence of the Meet Director, may require a mandatory scratch down. Immediate cash refunds will be made for any mandatory scratches.
 - All coaches and officials must wear their USA Swimming membership cards in a visible manner.
 - **Medical Supervision:** Lifeguards will be onsite during the meet.

ATTENTION HIGH SCHOOL ATHLETES: If you are a High School Athlete in season, you need to be Unattached from this meet. It is the Athlete’s responsibility to be Unattached from this meet. You can un-attach at the meet if necessary. This does not apply to Athletes swimming under the rules of the Nevada Interscholastic Activities Association (NIAA)

UNACCOMPANIED ATHLETES: Any USA Swimming Athlete-Member competing at the meet must be accompanied by a USA Swimming member-coach for the purposes of athlete supervision during warm-up, competition, and warm-down. If a member-coach of the Athlete's USA Swimming Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete's legal guardian to arrange for supervision by a USA Swimming member-coach. The Meet Director or Meet Referee may assist the athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete's USA Swimming Club member-coach.

RACING STARTS: Any athlete entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the Athlete or the Athlete's legal guardian to ensure compliance with this requirement.

ENTRY FEES: Individual event entry fee is \$4.50 per individual event, plus an \$10.00 participation fee per athlete. Relay entry fee is \$9.00 per relay team entry.

RELAY-ONLY ATHLETES: In order to verify athlete registration, all relay athletes who are not also entered in at least one individual event in this meet must be entered either online at <https://ome.fastswims.com/> or on the attached Club Relay Entry form.

ONLINE ENTRIES: To enter online go to <https://ome.fastswims.com/> to receive an immediate entry confirmation. This method requires payment by credit card. FastSwims charges a service fee, 6.5% of the total Entry Fees plus \$0.75 per transaction, regardless of number of athletes. Please note that the service fee is a separate fee from the Entry Fees. If you do not wish to pay the service fee, enter the meet using a mail entry. Entering online is a convenience, is completely voluntary, and is in no way required or expected of an athlete by Pacific Swimming. Online entries will be accepted through Wednesday, January 24, 2024 at 11:59 PM. *Late entries will not be accepted. No refunds.*

MAILED OR HAND-DELIVERED ENTRIES: To enter via U.S. mail or hand-delivery, entries must be submitted on the attached Consolidated Entry Form. Forms must be filled out completely and printed clearly with the athlete's best entry time. Entries must be postmarked on or before Monday January 22, 2024, or hand-delivered on or before Wednesday January 24, 2024 at 4:30 PM. *Late entries will not be accepted.* Request for confirmation of receipt of entries should include a self-addressed envelope.

Hand-delivered entries accepted Monday–Friday, 8:30 AM–4:30 PM, except closed for lunch (12 noon–1 PM) and holidays. *For alternative hand-delivery options, please contact the Meet Director.*

CHECK-IN: The meet will be deck-seeded. Athletes must check-in at the Clerk of Course. No event shall be closed more than 30 minutes before the scheduled start of the session. **Prior to 10:30 AM**, close of check-in for an event shall be no more than 60 minutes before the estimated start of the first heat of the event. **Close of check-in for all remaining events for that day shall be at 10:30 AM.** Athletes who do not check-in will not be seeded and will not be allowed to compete in that event. Athletes who wish to scratch (withdraw) from an event after the close of check-in are requested to inform the Referee on the starting end of the competition course.

SCRATCHES: Any athlete not reporting for or competing in an individual timed-final event shall not be penalized. Athletes who must withdraw from an event after it is seeded are requested to inform the Referee immediately.

RESTRICTIONS: • Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas, and in all areas used by athletes, during the meet and during warm-up periods.

- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- No propane heaters are permitted, except for snack bar/meet operations.
- All shelters must be properly secured.
- Deck changes are prohibited.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns, and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or their designee may ask that these devices be stored safely away from the public or removed

from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are except per applicable laws.

- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

ELIGIBILITY: • Athletes must be current members of USA Swimming and enter their name and registration number on the meet entry card as they are shown on their Registration Card. If this is not done, it may be difficult to match the Athlete with the registration and times database. The meet host will check all Athlete registrations against the SWIMS database and if not found to be registered, Athletes shall be required to register online via USA Swimming’s online member registration before being allowed to swim in the meet.

- Athletes must be attached to a Pacific Swimming Zone 2 club or be competing unattached while practicing with a Zone 2 club, pursuant to Article 203.3. **NOTE: Athletes who falsify their entry form by listing a club to which they are not legitimately associated will be rejected from the meet. Further, entry fees will not be refunded, and they may be referred to the Pacific Swimming Administrative Review Board for disciplinary action.**

- Athletes aged 9–10, 11–12, 13–14, 15–16, and 17–18 must have met the 2021–2024 USA Swimming Motivational “B” time standard for at least one event.

- Athletes aged 8 years or younger must have met the Pacific Swimming Motivational “PC-B” time standard for at least one event.

- Time standards may be found at <https://www.pacswim.org/swim-meet-times/standards>.

- Entries with “No Time” will be REJECTED.

- Entry times submitted for this meet may be checked against a computer database and may be changed in accordance with Pacific Swimming Entry Time Verification Procedures.

- Athletes with a disability are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding per Pacific Swimming policy.

- Athletes 19 years or older may compete in the meet for time-only (no awards). Such athletes must have met the standards for the 17–18 age group.

- Age on the first day of the meet shall determine the Athlete’s age for the entire meet.

SCORING: Top twenty (20) places for each age group (8 & under, 9–10, 11–12, 13–14, 15–16, and 17–18) per event will score points

AWARDS: For individual events, ribbons for 1st–10th places awarded for 8 & under, 9–10, 11–12, 13–14, 15–16, and 17–18 age groups. There are no awards for relay events. Individual High Point award for each girl and boy for 8 & under, 9–10, 11–12, 13–14, 15–16, and 17–18 age groups. Club awards for 1st, 2nd, and 3rd place in Small, Medium, and Large Club divisions. Divisions will be based on number of athletes entered in the meet.

ADMISSION: Free.

SNACK BAR & HOSPITALITY: A snack bar may be available. Coaches and working officials will be provided lunch.

MISCELLANEOUS: Facilities will not be provided after meet hours. No overnight parking is allowed.

MINIMUM OFFICIALS: The Meet Referee shall conduct an inventory of officials and shall compare the number of athletes entered against the number of officials that worked representing each club per session of the meet. Those clubs who have not provided sufficient officials per session of the meet, in accordance with the table below, shall be fined \$100 per missing official per session.
